Notice to Exhibitors

Mail Entries to: Carol Smith, 4305 N. W. 26th St., Oklahoma City, OK 73107. Entries will not be processed without fees. Make all checks payable to the German Shepherd Dog Club of Oklahoma and/or the German Shepherd Dog Club of Greater Tulsa, and not to the show secretary. All fees must be paid in U. S. Dollars.

Payment must accompany each entry. Fax, telephone or online entries must be accompanied by Visa/Mastercard payment. All entries received with a credit/debit card for payment will have a 3% service charge added. No entry shall be made and no entry will be accepted which specifies any conditions as to its acceptance. **ENTRIES CANNOT BE ACCEPTED, CANCELED, OR SUBSTITUTED** after entries have closed.

If because of riots, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the show, no refund of entry money will be made. **ENTRIES CANCELLED** prior to the closing date will be refunded less any service charges. If there is a judge change after the closing date, entries may be withdrawn and **ENTRY FEES WILL BE REFUNDED**, less any service charges, by notifying the Show Secretary prior to the beginning of judging.

The show will be open from 8:00 AM to 9:00 PM on Saturday, and from 8:00 AM to 6:00 PM on Sunday. Dogs may arrive prior to their scheduled judging time and may be excused when not required for further judging. The club will not be responsible nor obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging. Judges need not wait for any dog holding up a class. No space for unentered dogs is provided at this show.
